Organiser

Eligibility to participate

Participation in the competition is free of charge for all participants and does not obligate you to purchase from Onlineprinters. Participation in the competition is restricted to natural persons of full legal age (18 or older) with unrestricted legal capacity. Employees of Onlineprinters and their immediate families, as well as employees and family members of affiliated companies of Onlineprinters, or companies involved in the competition are not eligible to participate.

Exclusion from participation

Onlineprinters reserves the right to disqualify any participant from the competition at any time, following a prior hearing, in the event of any breach of these terms and conditions, the use of technical or other unauthorised means to manipulate the competition (such as automated scripts, hacking tools, Trojans, or viruses, as well as multiple or bulk entries unless expressly authorised by Onlineprinters), or any statutory violations. This also applies in the event of untruthful personal information, or the use of "fake profiles".

Onlineprinters expressly reserves the right to assert further claims, in particular the right to reclaim prizes.



Premature termination of the competition

Onlineprinters reserves the right to prematurely terminate, suspend, or modify the competition at any time without prior notice for good cause. A good cause within this meaning includes, in particular, unauthorised third-party intervention, technical problems with hardware or software, and legal infringements directly related to the execution of the competition. Should Onlineprinters terminate, suspend, or modify the competition, Onlineprinters will inform participants of this on the competition website. Prizes already won prior to the termination will be awarded regardless of the termination.

Warranty, limitation of liability

Onlineprinters provides no warranty for the prizes distributed within the scope of the competition; any rights arising from product defects are excluded.

Unless otherwise regulated in our General Terms and Conditions, any claims against Onlineprinters for damages arising out of or in connection with the competition are excluded.

Data protection

Onlineprinters is the data controller as defined by the General Data Protection Regulation (GDPR). The personal data collected (name, address, email address, IP address) will be processed and used by Onlineprinters for the purposes of managing the competition. For this purpose, data processing is carried out on the basis of Art. 6 (1) Sentence 1 lit. b GDPR for the performance of the contractually guaranteed services.

To provide our competition, we use technologies from Scratcher ApS, Røvsingsgade 68, 2100 Copenhagen, Denmark ("Scratcher"). Scratcher ApS acts on our behalf as the data processor pursuant to Art. 28 GDPR. Upon clicking to participate in the competition, the following information will be forwarded to Scratcher: Your IP address, date and time of access, volume of data transferred, and the requesting provider. This data will be used to manage the competition and will be deleted no later than 30 days after the end of the campaign, unless statutory retention obligations apply. Your IP address is generally anonymised after a period of seven days. Session cookies are set solely for the purpose of service provision and the accurate determination of winners. In the event that prizes need to be shipped, a delivery address will be collected for this purpose.

The legal basis is the performance of the contract pursuant to Art. 6 (1) Sentence 1 lit. b GDPR. Simultaneously, this serves to protect our legitimate interests in optimizing the presentation of our services, which prevail after conducting a legitimate interest assessment in accordance with Art. 6 (1) Sentence 1 lit. f GDPR.
